a. *ORDINANCE 12, 2017 - (2nd READING AND ADOPTION) BUSINESS CENTER AT THE GARDENS. A SEVERABILITY CLAUSE. AND AUTHORITY TO CODIFY: PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.

*RESOLUTION 22, 2017 - BUSINESS CENTER AT THE GARDENS. A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA GRANTING APPROVAL OF A PLANNED UNIT DEVELOPMENT (PUD) SITE PLAN FOR A 18.650-SQUARE-FOOT BUILDING WITH LABORATORY/RESEARCH AND DEVELOPMENT USE AND A MAJOR CONDITIONAL USE FOR A 99,183-SQUARE-FOOT SELF-STORAGE BUILDING LOCATED AT THE BUSINESS CENTER AT THE GARDENS PLANNED UNIT DEVELOPMENT (PUD); THE SUBJECT SITE IS GENERALLY LOCATED AT THE NORTHWEST CORNER OF THE INTERSECTION AT RIVERSIDE DRIVE AND BUCKEYE STREET, AS MORE PARTICULARLY CONDITIONS DESCRIBED HEREIN; PROVIDING OF APPROVAL: PROVIDING WAIVERS: PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.

b. ORDINANCE 13, 2017 – (1ST READING) CITY INITIATED LAND DEVELOPMENT REGULATION AMENDMENT. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, AMENDING CHAPTER 78. LAND DEVELOPMENT. BY AMENDING SUBSECTION 78-46(d); ADOPTING NEW SECTION 78-58 IN ORDER TO ADOPT REGULATIONS RELATING TO CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN; FURTHER AMENDING CHAPTER 78. AT SECTION 78-751 BY ADOPTING THE DEFINITION OF "CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN"; PROVIDING THAT EACH AND EVERY OTHER SECTION AND SUBSECTION OF CHAPTER 78. LAND DEVELOPMENT. SHALL REMAIN IN FULL FORCE AND EFFECT AS PREVIOUSLY ADOPTED; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
