Joint resolution authorizing the renewal of the State's Attorney's Law Enforcement Response to Drugs - Drug Prosecution grant program, awarded by the Illinois Criminal Justice Information Authority (ICJIA), including \$150,000 in federal funds.

- This is a renewal of the Law Enforcement Response to Drugs - Drug Prosecution Program, a federal grant administered through the ICJIA.
- Funding for this grant, formally known as the Multi-Jurisdictional Drug Prosecution grant, began in 1988, and has been renewed each year.
- The federal funds will provide funding for 69 percent of the salaries of one gang/narcotics prosecution division chief, one assistant state's attorney and one trained police investigator dedicated to the prosecution of drug related offenses covering the time period of October 1, 2017 through September 30, 2018.
- Program goals include increasing public safety and reducing the large social and economic cost of narcotics use by increasing awareness and skill levels of professionals involved in the identification, investigation and prosecution of drug trafficking.
- Sources of program funding include \$150,000 in federal funds and \$30,000 in matching funds provided from the State's Attorney's Asset Forfeiture Fund, for a grant program total of \$180,000.

Joint resolution authorizing the renewal of the State's Attorney's Violent Crime Victims Assistance (VCVA) grant program awarded by the Office of the Illinois Attorney General, including grant funding of \$31,000.

- This is a request to renew the VCVA grant administered through the Office of the Illinois Attorney General, with a grant period from July 1, 2017 through June 30, 2018.
- Funding for this grant began in 1990 and has been renewed each year.
- Grant program goals include the promotion of fairness, accountability and coordination of services for victims and witnesses of domestic violence, and the promotion of policy and procedure for domestic violence cases in order to improve response by law enforcement and court personnel.
- The grant will fund \$31,000 to offset the salary of a domestic violence victim witness coordinator (DV Coordinator).
- The DV Coordinator position and grant is already included in the State's Attorney's approved fiscal year (FY) 2017 budget.

Joint resolution authorizing an amendment for an extension and increase of federal funding for the State's Attorney's Victim of Crime Act (VOCA) Prosecutor Based Victim Services grant program number 215277, awarded by the Illinois Criminal Justice Information Authority (ICJIA), which will continue to support the program through December 31, 2017, and an emergency revenue appropriation of \$19,103.

- This grant extension is for the Prosecutor Based Victim Services program, a VOCA victim assistance grant administered through the ICJIA.
- The performance period of VOCA grant number 215277 was October 1, 2016 through September 30, 2017. The extension and increased grant funding of \$19,103 would continue to support the program for an additional three months, through December 31, 2017.
- The focus of this grant is to provide advocacy services to the currently underserved sexual assault victim population.
- The federal funds are allocated to 86 percent of the grant assigned sexual assault victim witness coordinator's salary and benefits.
- Sources of program funding for this extension include \$19,103 in federal funds and matching funds of \$4,775 in County contribution as budgeted in the State's Attorney's budget, for a grant program total of \$23,878.

Joint resolution authorizing an amendment and increase of federal funding for the State's Attorney's Victim of Crime Act (VOCA) Prosecutor Based Victim Services grant program number 215936, awarded by the Illinois Criminal Justice Information Authority (ICJIA), which will continue to support the program through December 31, 2017, and an emergency revenue appropriation of \$19,236.

- This grant extension is for the Prosecutor Based Victim Services program, a VOCA victim assistance grant administered through the ICJIA.
- The performance period of VOCA grant number 215936 was October 1, 2016 through

September 30, 2017. The extension and increased federal funding of \$19,236 would continue to support the program for an additional three months, through December 31, 2017.

- The focus of this grant is to provide advocacy services to the currently underserved misdemeanor domestic violence, elder abuse and aggravated battery victim population.
- The federal funds are allocated to 100 percent of the grant assigned domestic violence victim witness coordinator's salary and benefits, and additional program costs will be covered by match funds.
- Sources of program funding for this extension include \$19,236 in federal funds and matching funds of \$4,808, which is provided from the State's Attorney's Money Laundering Forfeiture Fund, for a grant program total of \$24,044.

Joint resolution accepting the Behavioral Health Treatment Court Collaborative (BHTCC) grant number 5H79SM061684, awarded by the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA) for the period of September 30, 2017 through September 29, 2018, which will continue to support the Nineteenth Judicial Circuit's programing in this area, and authorizing an emergency appropriation with offsetting revenue, in the amount of \$291,985.

- The SAMHSA awarded Lake County a four-year BHTCC grant in 2014.
- The annual award amount was \$340,231 but is subject to approval each year.
- The award for Federal Fiscal Year 2018 has been reduced to \$291,985.
- The grant is intended to enhance the various specialty courts operated by the Nineteenth Judicial Circuit Court. This includes Dialectical Behavior Therapy, housing counseling, an employment specialist, peer recovery services, and case management for specialty court clients. There is also funding for a required grant evaluator and for grant management.
- The four main goals of the grant are:
  - Increase stakeholder participation in the Nineteenth Judicial Circuit Court to address the behavioral health needs of adults involved with the criminal justice system;
  - Enhance the trauma-informed care of adults in Specialty Courts;
  - Improve the communication among BHTCC members in terms of resources, case management and referrals; and
  - Document outcomes.

Joint resolution accepting the Adult Redeploy Illinois (ARI) grant, awarded by the Illinois Criminal Justice Information Authority (ICJIA) for the period of July 1, 2017 through June 30, 2018, which will continue to support the Nineteenth Judicial Circuit's programing in this area, and authorizing an emergency appropriation with offsetting revenue, in the amount of \$225,440.

- The ARI Board recently announced that the Nineteenth Judicial Circuit was awarded

\$225,440 in ARI funding for the grant period of July 1, 2017 through June 30, 2018.

- The program will provide residential treatment for high risk and high need offenders who are chemically dependent, recovery coaching services, and access to recovery home services which will provide a continuum of care in the community.
- This resolution authorizes an emergency appropriation of \$225,440 and the execution of a program agreement to accept the grant funding. The grant does not require a match.

Joint resolution approving the 2017 Housing and Community Development Annual Action Plan, authorizing all necessary correspondence for the distribution and implementation of the plan with the United States Department of Housing and Urban Development (HUD).

- Following an initial Public Hearing on February 15, 2017 and two subsequent thirty-day public comment periods, a second public hearing on the 2017 Action Plan was held at the Housing and Community Development (HCDC) Commission meeting on July 19, 2017 before the recommendations advance to the Lake County Board for consideration.
- The fiscal year (FY) 2017 budget of the HUD has been finalized at the federal level. Lake County's combination of Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) and Emergency Solutions Grant (ESG) funds total \$3,998,914 which is an increase of 1.2 percent from the previous year, with the largest increase in HOME by \$32,478 (plus 2.9 percent) to \$1,157,197.
- The HCDC Commission voted to recommend the 2017 Action Plan for HCDC to the Health and Community Services and the Financial and Administrative Committees for their approval and recommendation that the plan be adopted by the Lake County Board at its August 8, 2017 meeting.
- During the Health and Community Services Committee meeting on August 1, 2017, an amendment was made to reallocate \$45,000 in the Lake County Affordable Housing Program funds from new senior rental housing in Mundelein (PIRHL, LLC) to Catholic Charities for emergency shelter (motel vouchers) for flood victims and general homelessness prevention.

Joint resolution authorizing an agreement for professional engineering services with Infrastructure Management Services (IMS), Rolling Meadows, Illinois, at a maximum cost of \$80,000, for the annual pavement testing services and associated components, appropriating \$100,000 of Matching Tax funds, and designated as Section 17-00219-00-ES.

- 2017 Pavement Management System, Field Testing: Consultant Agreement and Appropriation.
- The County approved an agreement for professional engineering services with IMS in 1986 to implement a pavement management system.
- IMS was the original supplier of said database information and has skill in pavement testing services that is necessary to update the database within the County's Automated Repair Guidance System (Argus).
- The pavement data in the system is updated on a yearly basis, utilizing information collected, using dynamic load testing and laser testing procedures.
- Approximately 25 percent of the County highway system is retested each year.
- Information from the pavement management system is used to generate recommended resurfacing projects for the next five years.
- In accordance with the Local Government Professional Services Selection Act, the recommended firm is IMS of Rolling Meadows, Illinois, at a cost of services of \$80,000.

- An appropriation of \$716,400 of Motor Fuel Tax funds and \$100,000 of Matching Tax funds must be made prior to a letting being held.

- The Lake County Board approved the replacement of the Countryside Manor Water Tower at their meeting in July 2016.
- The structure is in its final stage of completion and Verizon Wireless requested space on the water tower and adjacent property to install, maintain, and operate telecommunications equipment and antennas to provide wireless phone and data services to its customers.
- There is a need to enter into a lease agreement to provide Verizon Wireless access to the property at 30109 North Park Lane, Green Oaks, Illinois to install, remove, replace, modify, maintain, and operate the telecommunications equipment.
- The lease will provide revenue to Lake County in the amount of \$36,000 per year with a 10 percent increase at each five-year renewal period.
- It is hereby requested that the County Board Chair be authorized to execute the lease agreement with Verizon Wireless of Basking Ridge, New Jersey.

Joint resolution authorizing the addition of seven temporary positions to the General Operating Expense (GOE) for the purpose of providing staff relief at the Lake County Jail. The positions will be filled and managed by the Sheriff's Office (SO).

- There are various factors that impact the jail population, the facility and how staffing is managed. Accordingly, the population tends to fluctuate on a weekly basis. When the daily average exceeds 600, the need to open an additional pod based on the current operational model is activated.
- County Administrator's Office (CAO) and SO have been monitoring the staffing situation at the jail. At this time, it has elevated to a budget and staff issue.
- Based on current staffing and budget trends, there is an immediate need to add seven additional positions to staff the additional jail pod (approx. \$750K) to the GOE account. With that understanding, CAO will utilize previously approved funding in the County's payroll contingency account to provide staffing relief.
- This funding is a one-time and temporary solution. CAO encourages SO to consider operational improvements to insure adequate staffing at the jail and develop a permanent solution. These positions can be reduced should the additional pod no longer be required.
- Due to increased staffing needs, without an adjustment in positions, the SO budget is on track to potentially end the year with a budget shortfall. This overage is primarily due to actual and projected overtime to staff the additional jail pod, as well as jail medical costs.

- The County and the Lake County Forest Preserve District (LCFPD) entered into an agreement effective April 28, 2000, as amended, providing for a land exchange and allowing the County to acquire a license from the LCFPD for the purpose of creating "wetland banking credits" that could be used for future public roadway improvements.
- A total of five bids were received, ranging from \$1,254,428.47 to \$2,377,394.20 and the

lowest responsible bidder is Semper Fi Land Services, Inc., Aurora, Illinois, in the amount of \$1,254,428.47.

- This project is included in the highway improvement program.

Joint resolution authorizing the waiver of flood repair-related permit fees and the reduction of septage disposal fees.

- On July 12, 2017, due to the significant widespread flooding occurring throughout the County, the County Board Chairman proclaimed a disaster in Lake County.
- Also on July 14, 2017, Governor Rauner proclaimed three counties, including Lake County, State disaster areas.
- The flooding has resulted in widespread damage to structures and surface grading in the unincorporated areas and widespread inundation of septic tanks and fields throughout impacted areas.
- For those flood-related structure repairs and top-dressing necessitating permits, and for those inundated septic tanks and fields requiring septage disposal, fees are required by ordinance.
- To assist in disaster relief, such permit fees will be waived and septage disposal fees will be reduced as provided in Appendix A.

- Upon receiving satisfactory grades on the examination and certification from IDOT, Shane Schneider, P.E., will be appointed as County Engineer.

- It is anticipated that the Committee would annually meet (a) approximately twice in the fall to develop the annual Legislative Agenda, (b) once during the General Assembly's veto session, (c) once per month during the General Assembly's regular session, and (d) as otherwise needed.
- In accordance with the County Board Rules of Order and Operational Procedure, the Financial and Administrative Committee will remain responsible for legislation and charged with making a final recommendation on the Legislative Agenda to the County Board.
- The Committee, which would be in place immediately upon creation and dissolve on November 30, 2018, would be comprised of the following members: Co-Chairs Diane Hewitt and Sidney Mathis, and Members Paul Frank, Michael Rummel, and Jeff Werfel.
