

Calendar grid for 2018 showing months from January to December with days of the week and dates.

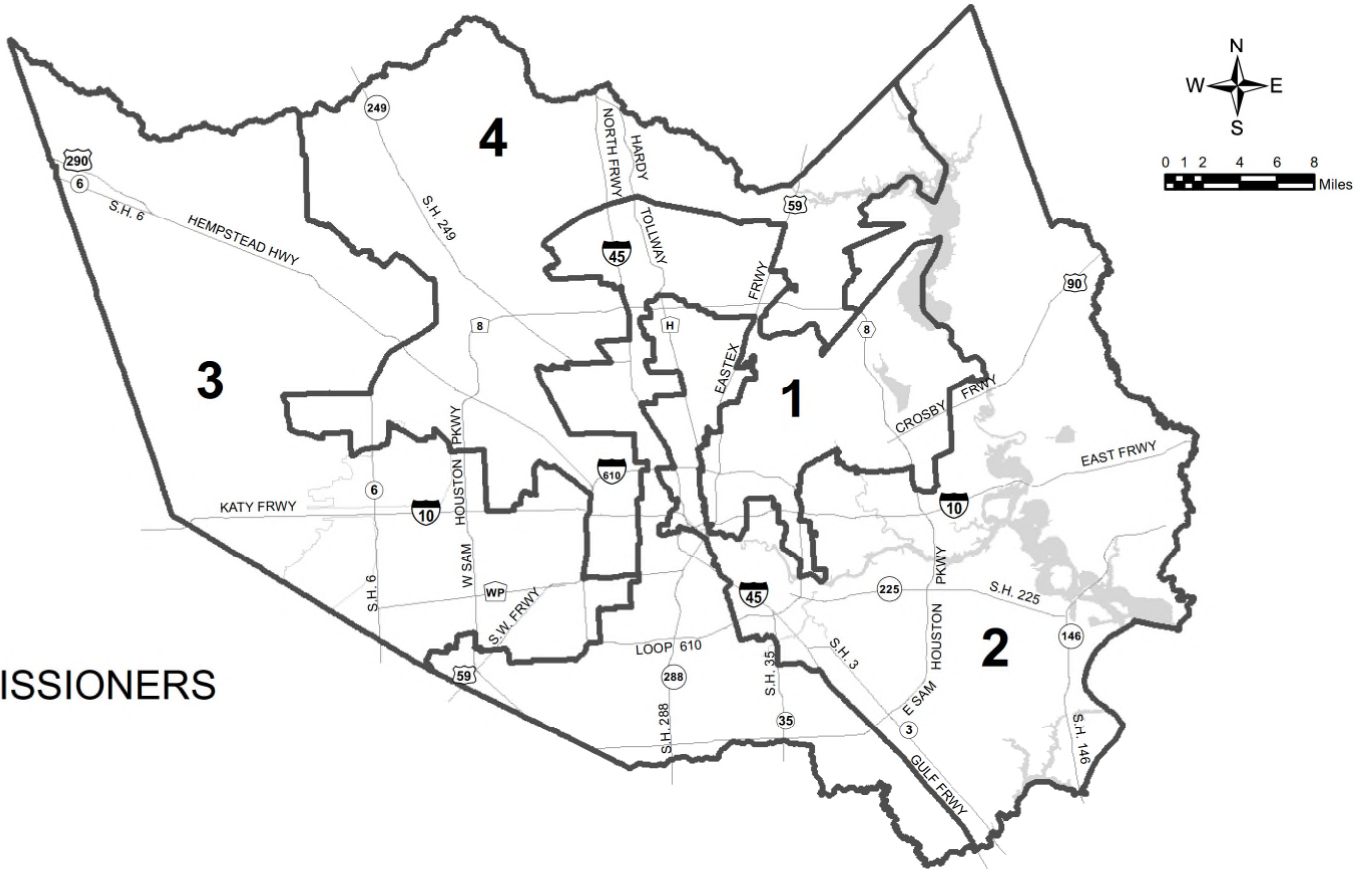

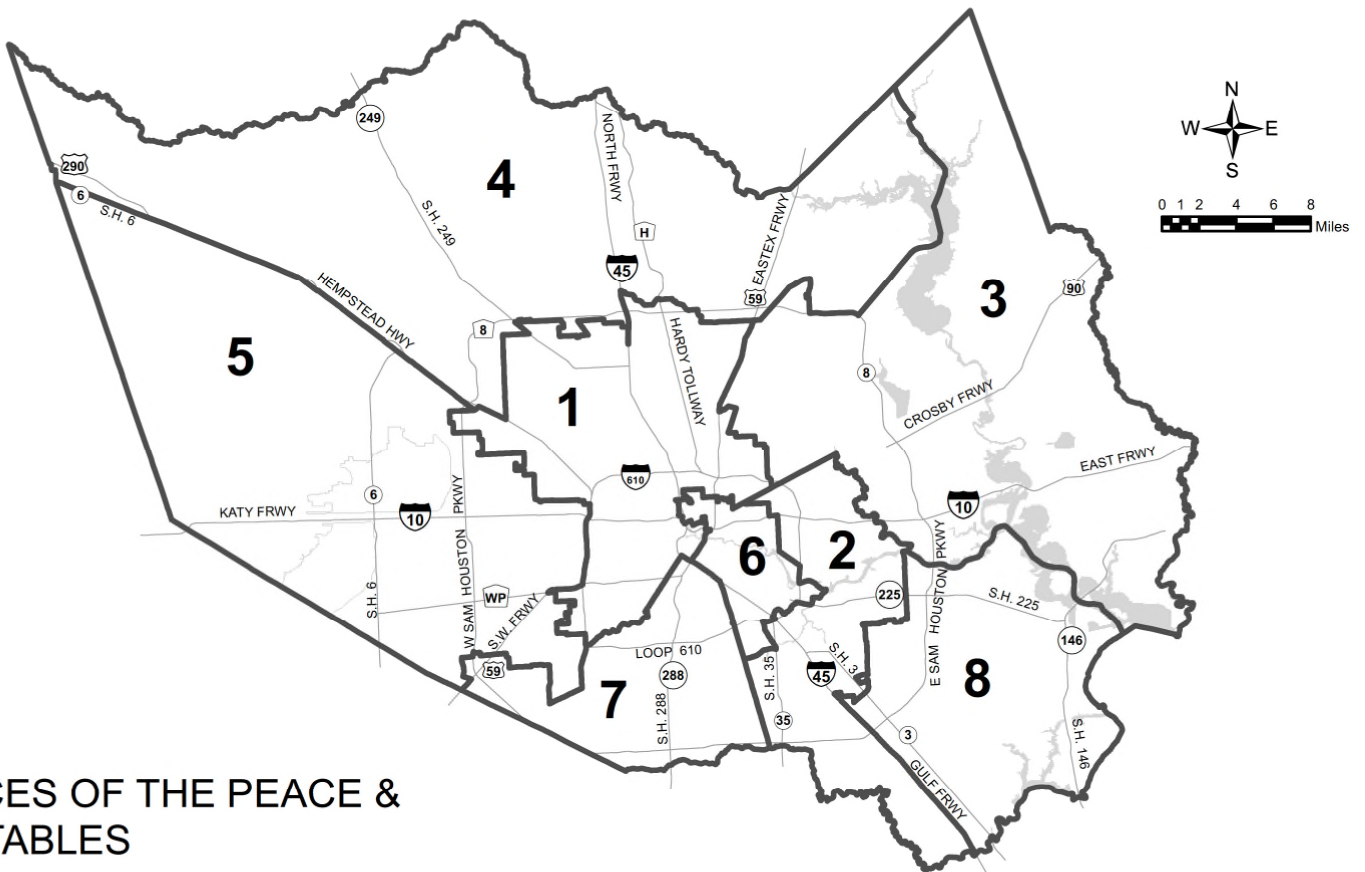
Calendar grid for 2019 showing months from January to December with days of the week and dates.
