**Permian Basin Energy Sector Funding Update (Presentation)**

(2) **Statewide Truck Parking Study (Presentation)**

*The Statewide Truck Parking Study represents the first comprehensive analysis of truck parking in Texas. The study identifies and prioritizes current and future truck parking needs and challenges, as well as potential impacts across the state. The study outlines comprehensive policy, outreach, coordination, technology, program, and infrastructure recommendations, and an implementation roadmap for addressing the identified needs. Staff will provide an overview of the findings and recommendations of the study.*

(3) **Speed Zones (Presentation)**

*Staff will provide information on setting of regulatory speed limits on publicly traveled roadways, including those under repair or reconstruction, as an important tool in promoting safety and efficient operations on the highway system.*

c. **Rural and Statewide Connectivity (Presentation)**

*Staff will present and facilitate discussion on statewide and rural connectivity.*
