BACKGROUND: On November 4, 2014, a Municipal Election was held for the purpose of electing a Mayor-At-Large and District 2 Commissioner.

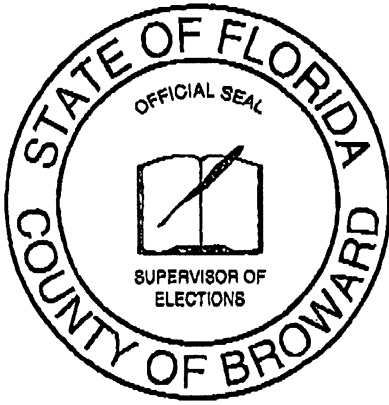
For the Mayor-at-Large a total of 16,776 votes were cast, with Mayor Harry Dressler receiving 10,644 votes and Mike Gelin receiving 6,132 votes.

For the District 2 Commissioner a total of 4,499 votes were cast with Vice Mayor Michelle J. Gomez receiving 3,109 and Stewart Jackson Webster receiving 1,390 votes.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, DECLARING THE RESULTS OF THE NOVEMBER 4, 2014 GENERAL ELECTION FOR CITY COMMISSION DISTRICT 2 AND THE OFFICE OF MAYOR-AT-LARGE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a General Election was held on November 4, 2014, wherein the electorate of the City of Tamarac elected one candidate for the Office of Commission Representative from District 2 and one candidate for the Office of Mayor-at-Large; and

WHEREAS, at the end of qualifying on June 20, 2014 the Commission Representative from District 4 had no opponent, therefore, Debra Placko was deemed elected to serve as the Commission Representative for District 4; and

WHEREAS, the Broward County Canvassing Board has canvassed the results of the machine voting and absentee ballots and has certified such results to the City Clerk of the City of Tamarac; and

WHEREAS, the City Clerk has reviewed the certification from the Broward County Canvassing Board and has presented their findings to the City Commission for a formal Certification and Declaration of the results; and

WHEREAS, the City Commission of the City of Tamarac, Florida, deems it to be in the best interests of the citizens and residents of the City of Tamarac to declare the results of the November 4, 2014 General Election for City Commission District 2 and the Office of Mayor-at-Large and to deem Debra Placko Commission Representative for District 4.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
CITY OF TAMARAC, FLORIDA:

SECTION 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

SECTION 2: That the following are the certified results of the votes received by candidates seeking the Office of Commission Representative from District 2 at the General Election held November 4, 2014:

Michelle J. Gomez	<u>3,109</u>
Stewart Jackson Weber	<u>1,390</u>

SECTION 3: That **Micheller J. Gomez**, having received the highest number of votes cast is therefore declared to have been elected as Commission Representative, District 2, of the City of Tamarac for a term of four years.

SECTION 4: That the following are the certified results of the votes received by candidates seeking the Office of Mayor-at-Large at the General Election held November 4, 2014:

Mike Gelin	<u>6,132</u>

SECTION 5: That **Harry Dressler**, having received the highest number of votes cast is therefore declared to have been elected as Mayor-at-Large, of the City of Tamarac for a term of four years.

SECTION 6: That Debra Placko, having run unopposed for Commission Representative for District 4 is deemed to be elected the Commission Representative for District 4 of the City of Tamarac for a term of four years.

SECTION 7: All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 8: If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

SECTION 9: This Resolution shall become effective immediately upon its passage and adoption.

**RE: Temporary Resolution #12579 –
Election of Vice Mayor**

Recommendation: That the Mayor and City Commissioners elect a Vice Mayor from among the commissioners to serve a one year term from November 18, 2014 through November 2015.

Issue: The current term of Vice Mayor will expire and a new Vice Mayor must be elected.

Background: Section 4.03 of the Tamarac Charter provides for the election of a Vice Mayor, and stipulates in part that: “Beginning November 2008, and each November thereafter, no earlier than the third Tuesday, a majority of the commissioners shall elect a vice-mayor. The Vice Mayor shall serve a term of one year and shall not serve successive one-year terms.”

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, ELECTING A VICE MAYOR TO SERVE A TERM OF ONE YEAR BEGINNING NOVEMBER 18, 2014 AND ENDING NOVEMBER 2015, WITH NO SUCCESSION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 4.03 of the Tamarac City Charter provides in pertinent part: “. . . Beginning November 2008, and each November thereafter, no earlier than the third Tuesday, a majority of the commissioners shall elect a vice-mayor. . .”; and

WHEREAS, Section 4.03 of the Tamarac City Charter further provides that “. . . The vice-mayor shall serve a term of one year and shall not serve successive one year terms.”; and

WHEREAS, the City Clerk and City Manager recommend the City Commission elect a Vice-Mayor to serve a one-year term with no succession; and

WHEREAS, the City Commission of the City of Tamarac deems it to be in the best interests of the citizens and residents of the City of Tamarac to elect a vice-mayor to serve from November 18, 2014 through November 2015 with no successive one year terms.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA:

SECTION 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

SECTION 2: That _____ is elected to serve as Vice Mayor, for a term beginning November 18, 2014 and ending November 2015, with no succession.

SECTION 3: All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

SECTION 5: This Resolution shall become effective immediately upon adoption.
