**PLANNING, BUILDING AND ZONING COMMITTEE****17**     [15-0905](#)

Joint resolution to approve an Intergovernmental Agreement with the Illinois Office of the Comptroller to obtain access to the Comptroller's Local Debt Recovery Program.

- In 2011 the county implemented an administrative adjudication program for use with animal care & control and nuisance violations. In the four years since, other county departments and a municipality have incorporated violation cases into the County's administrative adjudication program.
- Numerous cases remain open due to lack of payment of fines and fees despite the County's use of private collections.
- The Illinois Office of the Comptroller administers the Local Debt Recovery Program which can be utilized to collect unpaid local government fines and fees (via garnishment of a portion of debtors' State payments). Following the passage of this agreement the county will begin working with the Illinois Office of the Comptroller to implement the system for use with administrative adjudication fines and fees.

Joint resolution to enter into a contract for consulting services with Beth Malloy and Associates, Chicago, Illinois, in a not to exceed amount of \$266,420 to provide consulting services for the implementation phase for the replacement of the land management, code enforcement and permitting system for Lake County.

- In July 2015 the County Board authorized the execution of a contract with Tyler Technologies, Duluth, GA for the purchase of Software and Professional Services of a new Land Management System.
- This proposal is for an outside vendor to manage the implementation of the new Land Management System within the departments of Planning, Building & Development, Public Works, Division of Transportation, the Stormwater Management Commission, and the Health Department. The vendor will function as the project manager on behalf of the county during the anticipated implementation period of 18-24 months.
- Implementation services and project management were planned for and included in the project budget as approved in FY2015 Budget.

- The RFP was sent to 23 vendors and proposals were received from two non-local vendors; no local vendors submitted a proposal for this service.
- Based on the criteria set forth in the RFP to provide consulting services for the implementation phase of the Land Management System, the proposal submitted by Beth Malloy and Associates is deemed the most qualified and most favorable for Lake County.
- The contract includes consulting services at a contract amount not to exceed \$266,420.

Joint resolution authorizing the renewal of the State's Attorney's Prosecutor Based Victim Services grant program, awarded by the Illinois Criminal Justice Information Authority (ICJIA), including \$61,127 in federal funds.

- This grant renewal is for the Prosecutor Based Victim Services program, a victim assistance grant administered through ICJIA for the performance period of October 1, 2015 through September 30, 2016.
- Funding for this grant began in 1991 and has been renewed each year.
- The focus of this grant is to provide advocacy services to the currently under served sexual assault victim population.
- The federal funds are allocated to 75 percent of the grant assigned Sexual Assault Victim Witness Coordinator's time and salary.
- Sources of program funding include federal funds in the amount of \$61,127; matching funds of \$15,282, consisting of \$7,755 from the State's Attorney's Asset Forfeiture Fund and \$7,527 in County contribution as budgeted in the State's Attorney's budget, for a grant program total of \$76,409.

- This grant renewal is for the Prosecutor Based Victim Services program, a victim assistance grant administered through ICJIA for the performance period of October 1, 2015 through September 30, 2016.
- Funding for this grant began in 2010 with American Reinvestment and Recovery Act (ARRA) funding.
- The focus of this grant is to provide advocacy services to the currently under served misdemeanor domestic violence, elder abuse and aggravated battery victim population.
- The federal funds are allocated to 94 percent of the grant assigned Domestic Violence Victim Witness Coordinator's salary and benefits, and additional program costs will be covered by match funds.
- Sources of program funding include federal funds in the amount of \$61,553 and matching funds in the amount of \$15,388, which is provided from the State's Attorney's Money Laundering Fund for a grant program total of \$76,941.
- Additional salary or benefit costs for this position will be reimbursed by the State's Attorney's Money Laundering fund.

- The miscellaneous metals work in this request for proposal generally includes installation of all metal stairs, metal railings, and other miscellaneous metal products for all phases of the courthouse expansion project.
- The Lake County Board has authorized Clark Construction Group LLC of Chicago, Illinois, to proceed with a Guaranteed Maximum Price (GMP) for the infrastructure & interior work pursuant to their contract for CMAR services.

- Cook County, Illinois, is the lead agency for the Lake Cook Road, from Raupp Boulevard to Hastings Lane, improvement and will construct the improvement in two stages.
- Cook County anticipates letting Stage 1 of the improvement in 2016, Hastings Lane to Weiland Road, and letting Stage 2 of the improvement in 2017, Weiland Road to Raupp Boulevard.
- Cook County will be acquiring right-of-way along two Lake County highways, Weiland Road and Buffalo Grove Road, for the Lake Cook Road improvement.
- Before right-of-way acquisitions can proceed, an agreement with Cook County, and appropriation and condemnation authority are necessary.
- This resolution authorizes an agreement with Cook County, Illinois, for the acquisition of necessary right-of-way, by agreement or condemnation, and other right-of-way costs associated with the improvement of Lake Cook Road, from Raupp Boulevard to

Hastings Lane, and appropriates \$185,000 of ¼% Sales Tax for Transportation funds for the Lake County portion of this improvement.

- This County Board at its meeting of November 11, 2014, approved \$115,000 for the January 1, 2015, thru December 31, 2015, contract period.
- The number of JULIE ticket screening and locate requests will exceed our 2015 estimate due to increased construction activity.
- This resolution is appropriating a supplemental amount of \$80,000 for the 2015 contract period.

Joint resolution authorizing execution of an agreement with Quality Power Solutions, Madison, Wisconsin, in the amount of \$109,142 for consulting services associated with the Public Works Arc Flash South Area Study.

- Electrical control systems are key components required to operate lift stations and motor control systems that run the southeast sanitary sewer collection system, many of which have been in continuous service for over 35 years.
- Current National Fire Protection Association (NFPA) regulations require that electrical control systems be analyzed for potential electrical hazards and properly labeled to protect the health and safety of any persons operating or working on these electrical systems.
- Engineering consulting services are needed to analyze the existing electrical equipment, prepare one line electrical system plans, prepare a system electrical hazard report and, accordingly, label all electrical equipment.
- In accordance with the Local Government Professional Services Selection Act, the recommended firm is Quality Power Systems of Madison, Wisconsin.
- This resolution authorizes execution of a professional services agreement with Quality Power Solutions of Madison, Wisconsin, in the amount of \$109,142.

Ordinance amending a previous ordinance designating the voting sites assigned to four of the 415 precincts in Lake County Townships.

- After reviewing voting sites for the March 15, 2016 General Primary Election and November 8, 2016 General Election, voting site changes are proposed to provide better voting site locations to those precincts affected either by a site that has requested to discontinue serving as a polling place due to parking and space limitations or by a site that will be under construction during the time of the elections.
- Re-assigns each precinct to an appropriate voting site which has sufficient parking and voting space as well as full accessibility for all voters.

**FINANCIAL AND ADMINISTRATIVE COMMITTEE****34**     [15-0886](#)

Ordinance and resolution granting authority to charge a fee to cover energy costs at its Electric Vehicle Charging Stations.

- The Strategy for a Sustainable Lake County and the operations plan for implementing the Board's Strategic Plan, encourages the exploration and use of sustainable transportation choices to reduce vehicle emissions.
- In November 2014, taking advantage of state and federal incentives for all-electric vehicles, the County purchased three all-electric vehicles (EVs) and three charging stations.
- The County is installing EV charging stations at Central Permit Facility, 3010 Grand Avenue and the parking garage of the County Administration Tower in Waukegan. Each charging station is equipped with two charge ports. One port is reserved for county vehicles only and the other will be available for the public and employees to charge personal vehicles.
- This ordinance gives the County the authority to impose a reasonable fee pursuant to 55ILCS/5-11004 for the electricity that will be utilized at these EV charging stations.
- The County is electing at this time to observe the electric usage at the EV charging stations, assess usage, costs, and other related matters. Staff will report back to the findings of this pilot program for the Board's reconsideration.

Resolution authorizing a contract with Crowe Horwath LLP, Oak Brook, Illinois, in the amount not to exceed \$120,000, for a vulnerability assessment.

- Lake County Information Technology (IT) is seeking professional services to assist in strengthening Lake County's security posture.
- A Request for Proposal (RFP) was issued to identify a qualified firm for consulting services to complete internal and external vulnerability assessments.
- Lake County extended requests to 50 vendors and received five proposals.
- A review committee comprised of staff from IT, Risk, County Administrators Office, Health Department, Courts, and Purchasing determined that the proposal submitted by Crowe Horwath LLP is the most qualified and favorable proposal for Lake County.

- The resolution authorizes a one year agreement in the amount not to exceed \$120,000.

Resolution ratifying an emergency procurement with Iskalis Interiors, Inc of Gurnee, Illinois, in the amount of \$32,200 and Servpro of Gurnee, Illinois, in the amount of \$42,603.07 for the emergency repairs to the first floor of the Babcox Justice Complex.

- Construction on the Lake County Courthouse Expansion Project caused a sewer line to be struck on July 27, 2015 and caused a backflow into the first floor of the Babcox Justice Complex.
- Facilities identified flooding in limited areas on the first floor and basement of the Babcox Justice Complex.
- Servpro of Gurnee, Illinois, a firm specializing in cleanup and restoration, was brought on site within two hours to thoroughly and appropriately clean and disinfect all floors and hard surfaces.
- Iskalis Interiors of Gurnee, Illinois, was contracted to replace all soiled carpet and other flooring materials as appropriate.
- Pursuant to the Lake County Purchasing Ordinance emergency procurements are made when there exists a threat to public health, welfare, or safety, or to prevent or minimize serious disruption of government services.
- Pursuant to Article 6, Section 103, the Facilities Manager submitted a written determination of the basis for the emergency and the certification that the selection of the contractors was appropriate.
- Lake County will seek reimbursement from the Contractor for the costs associated with the repairs to the Babcox Justice Complex.

Resolution accepting the annual Emergency Management Assistance grant funding from the Illinois Emergency Management Agency (EMA) for federal fiscal year 2015 Emergency Management Performance Grant pass through funds in the maximum amount of \$154,181.14.

- Lake County has applied for and has been awarded an annual allocation from the Illinois Emergency Management Agency on behalf of the Lake County Emergency Management Agency.
- This funding supports the County in developing and maintaining an effective integrated and program.
- This funding provides for quarterly reimbursement of up to 50 percent of allowable program costs for the Lake County Emergency Management Agency.
- The actual amount of funding is dependent on both the county's expenditures and the availability of federal funds to the Illinois Emergency Management Agency, which is dependent on the federal budget and Federal Emergency Management Agency grant program guidance.
- The maximum funding available to Lake County through this grant is \$154,181.14.
- This grant provides for Emergency Management program activities between October 1, 2014, and September 30, 2015.
- Revenue from this grant will offset currently budgeted expenses; no additional expenses are budgeted as a result of this grant.
- Lake County invests local funding in emergency management program activities to satisfy the grant match requirements.

Resolution directing the Lake County Zoning Board of Appeals to conduct a public hearing to consider certain proposed text amendments to the Unified Development Ordinance of Lake County, Illinois (Chapter 151 of the Lake County, Illinois Code of Ordinances) adopting the latest floodplain maps prepared by the Federal Emergency Management Agency.

- The Federal Emergency Management Agency (FEMA) has re-evaluated and revised the Flood Insurance Study (FIS) and the Flood Insurance Rate Map (FIRM) within Lake County. Appendix M along with minor text amendment of the Unified Development Ordinance of Lake County (UDO) has been amended.
- These text amendments must be adopted prior to February 17, 2016, so Lake County may remain in good-standing in the FEMA National Flood Insurance Program (NFIP) and continue to be a Stormwater Management Commission (SMC) "Certified Community."
- State law requires that the Zoning Board of Appeals hold a public hearing to amend the text of the UDO.
- On March 13, 2001, the Lake County Board authorized the Planning, Building and Zoning Committee (PB&Z) to forward any future proposed UDO text amendments relating to WDO revisions directly to the Zoning Board of Appeals (ZBA) and to direct the ZBA to conduct a public hearing to consider such amendments.
- The Planning, Building and Development Department staff has reviewed the proposed amendments and recommends that the text of the UDO be amended in accordance with Exhibit A.

Resolution authorizing the temporary closure of a portion of Route 173 on October 9, 2015.

- The Sheriff's Office is working with the Beach Park School District and is planning an Active Shooter Drill that will take place on October 9, 2015.
- The main objective of the drill is to use National Incident Management Systems (NIMS) standards to test operational coordination, interoperability and the core capabilities of a multiagency response to a critical incident.
- In order to maintain a safe environment for first responders involved in this drill we request authorization to temporarily close Route 173, between Route 41 and Kilbourne Road, from 7 a.m. to 1 p.m.
- By closing Route 173 first responders will be able to cross the road safely between the staging area at Van Patten Wood Forest Preserve and Beach Park School and will allow fire trucks to park along Route 173 in front of the school.
- Road closure signs will be placed on Route 173 several days before the road closure to inform motorists of said closure.

Joint resolution authorizing and emergency appropriation in the amount of \$430,000, with offsetting revenue, in the Circuit Court's budget.

- Public Act 98-1132 mandates that jurors will be paid \$25 for the first day of service and \$50 per day for every day after, effective June 1, 2015.
- This increase has resulted in juror fees increasing from an average of \$3,900 per week to \$9,800 per week; a 151 percent increase.
- The Court's budget is not adequate to absorb this increase which is estimated at \$150,000 for the remainder of fiscal year (FY) 2015.
- Additionally, the arrest of over twenty individuals under the Racketeer Influenced and Corrupt Organizations Act (RICO) has necessitated hiring several conflict attorneys.
- These attorneys are appointed only in cases where having an attorney from the Public Defender's Office would be a conflict of interest.
- Due to the seriousness and complexity of the criminal charges, attorney fees are estimated to be in the \$30,000 to \$50,000 range per attorney.
- The Court's budget is not adequate to absorb these unanticipated costs.
- The Administrative Office of the Illinois Courts (AOIC) recently announced that the Nineteenth Judicial Circuit would receive \$1,225,053 more in salary reimbursement for State Fiscal Year (SFY) 2015 than previously awarded and a portion of these funds is being emergency appropriated to cover the above unexpected expenses.
- An emergency appropriation of \$150,000 for juror fees and \$250,000 for conflict attorneys, with offsetting revenue from salary reimbursements, is requested.

- County funds in the amount of \$1,200,000 were already reserved for this project in fiscal year (FY) 2014. The remaining \$750,000 to fully fund the project will be appropriated from Health Department Fund balance.
- This resolution appropriates funds in Fund 210 Health Department for the Zion Community Health Center project in the amount of \$750,000 from the fund balance in Fund 210 Health Department Fund; the remaining fund balance after this transaction is estimated to exceed \$30,000,000.

Joint resolution authorizing an emergency appropriation in the amount of \$1,120,308 in the Community Development Neighborhood Stabilization (NSP 1 and 3) Program budgets as a result of revenue from the sale of homes purchased under the program.

- The NSP has been operating successfully and has resulted in the sale of previously foreclosed homes to income-qualified persons.
- These homes were originally purchased and rehabilitated using NSP funds.
- Proceeds from the sale of these homes will be used to purchase and rehabilitate more homes pursuant to the program design and requirements.
- An emergency appropriation is necessary to budget revenue received from the sale of homes and expense to reinvest in the NSP program.
