URBAN GROWTH BOUNDARY (UGB), POLICY 1.2.4.1.(a)2., AND POLICY 1.2.4.4.(b) IN ORDER TO AMEND THE URBAN GROWTH BOUNDARY TO INCLUDE CERTAIN REAL PROPERTY LOCATED ON THE NORTH SIDE OF NORTHLAKE BOULEVARD, EAST OF GRAPEVIEW BOULEVARD, WEST OF BAY HILL DRIVE, AND SOUTH OF BEELINE HIGHWAY: PROVIDING FOR COMPLIANCE WITH ALL REQUIREMENTS OF CHAPTER 163, FLORIDA STATUTES; PROVIDING FOR TO THE FLORIDA DEPARTMENT OF ECONOMIC TRANSMITTAL OPPORTUNITY (DEO): PROVIDING A CONFLICTS CLAUSE. *ORDINANCE 4, 2016 - (2ND READING AND ADOPTION) AVENIR. AN C. ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS. FLORIDA REZONING CERTAIN REAL PROPERTY. SUCH PROPERTY BEING COMPRISED OF 4,763 ACRES IN SIZE, MORE OR LESS, AND LOCATED ON THE NORTH SIDE OF NORTHLAKE BOULEVARD, EAST OF GRAPEVIEW BOULEVARD, WEST OF BAY HILL DRIVE, AND SOUTH OF BEELINE HIGHWAY, KNOWN AS THE AVENIR PCD; PROVIDING THAT THIS PARCEL(S) OF REAL PROPERTY, WHICH IS MORE PARTICULARLY DESCRIBED HEREIN, SHALL BE **REZONED** FROM DEVELOPMENT AREA (PDA) DISTRICT TO PLANNED COMMUNITY DEVELOPMENT (PCD) OVERLAY WITH AN UNDERLYING ZONING DESIGNATION OF MIXED USE DEVELOPMENT (MXD) DISTRICT WITH A CONSERVATION PRESERVED LAND OVERLAY ON 2.407 ACRES: PROVIDING THAT THE ZONING MAP OF THE CITY OF PALM BEACH GARDENS BE AMENDED ACCORDINGLY; PROVIDING A CONFLICTS CLAUSE AND A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.
