## 16 <u>16-1057</u>

Joint resolution authorizing an intergovernmental agreement between the City of Park City and the County of Lake for enhanced 9-1-1 emergency telephone service.

- This agreement is made pursuant to the Constitution of the State of Illinois of 1970, Article VII, Section 10 and the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., between the City of Park City, Illinois, on behalf of the Park City Emergency Telephone System Board (ETSB) and the County of Lake, Illinois, on behalf of the Lake County ETSB.
- Public Act 99-0006, effective January 1, 2016, requires any ETSB that serves fewer than 25,000 people to consolidate its emergency telephone services.
- Park City has filed its Consolidation Waiver Request with the Illinois Statewide 9-1-1 Advisory Board and the Statewide 9-1-1 Administrator seeking to dissolve the Park City ETSB as an administrative entity and include Park City in the emergency telephone system area served by the Lake County ETSB.
- Park City passed ordinances 2016-0-16 and 2016-0-17 dissolving the Park City ETSB and indicating its intention to join with the Lake County ETSB.
- It is the desire of Park City and the County of Lake, on their own and on behalf of their

respective emergency telephone system boards, as parties, to enter into this Intergovernmental Agreement.

## 17 <u>16-1095</u>

Ordinance to repeal the civil alternate juror fees established pursuant to Public Act 098-1132.

- Public Act 098-1132 effective on June 1, 2015, reduced the size of juries for civil cases from twelve to six jurors.
- Public Act 098-1132, also provided an additional fee for each alternate juror requested, with that fee to be established by the county.
- On August 11, 2015, Lake County adopted Section 35.25 of its Code or Ordinances establishing the alternate juror fee in accordance with Public Act 098-1132.
- The statutory authority under which Section 35.25 was adopted has been deemed unconstitutional, and the County no longer has the statutory authority to impose an alternate juror fee.
- It is recommended that the County repeal the civil alternate juror fee.

## 18 <u>16-1096</u>

Ordinance to establish fees for necessary attendants of grand and petit jurors.

- 55 ILCS 5/4-11001 sets forth juror fees to be paid for necessary attendants of grand and petit jurors, commonly known as juror fees.
- Public Act 098-1132, effective June 1, 2015, increased the fees to be paid to jurors.
- The statutory authority under which the fees were increased has been deemed unconstitutional.
- 55 ILCS 5/4-11001 provides that the County Board may establish a juror fee higher than that provided in the statute.
- The statutory juror fee is minimal and it is to the benefit of Lake County residents, serving as jurors, to set a fee higher than the minimal that is required by Illinois statutes.
- This Ordinance establishes the fees, and other cost reimbursements, that will be paid to jurors in Lake County.
- Jurors will be paid \$5 for days 1 and 2 of jury service, \$7.50 for days 3, 4 and 5 of jury service, \$10 for each day of jury service beyond day 5, plus \$5 toward meal cost for each full day of jury service.
- In addition, Jurors will be paid for travel expenses to the Lake County Courthouse for each day of jury service based upon the juror's residential zip code in an amount not less than \$4 and no more than \$10.

## 19 <u>16-1035</u>

Ordinance providing for the establishment of an altered speed zone for 45 miles per hour (M.P.H.), currently designated 55 M.P.H., on Townline Road, located in Avon Township, in conformity with Chapter 625 - Section 5/11-604 of the Illinois Compiled Statutes.

• <u>Township Speed Zone Ordinance: Townline Road in Avon Township.</u>

- An ordinance is required to establish speed zones.
- The necessary speed studies have been undertaken.
- This speed study was requested by the Avon Township Highway Commissioner.

## 20 <u>16-1065</u>

Joint resolution authorizing a contract with AC Pavement Striping Company, Elgin, Illinois, in the amount of \$980,070.05, for the 2016 microsurfacing of Rollins Road, from Hook Drive to Illinois Route 132, and designated as Section 16-00080-61-RS.

- <u>2016 Microsurfacing of Rollins Road, from Hook Drive to Illinois Route 132: Contract</u> <u>Award.</u>
- Microsurfacing is a pavement preservation technique.
- Rollins Road, from Hook Drive to Illinois Route 132, is in need of microsurfacing.
- This microsurfacing improvement has been identified within the County's pavement management system, and is included in the 2016 program.
- A total of two bids were received, ranging from \$980,070.05 to \$1,037,572.36, and the lowest responsible bidder is AC Pavement Striping Company, Elgin, Illinois, in the amount of \$980,070.05.

## 21 <u>16-1067</u>

Joint resolution authorizing a contract with Alliance Contractors, Inc., Woodstock, Illinois, in the amount of \$618,683.50, for the repair of six bridge abutments on the North Shore Bike Path over the Skokie River, the Canadian National Railroad, and the Metra Railroad, and designated as Section 16-00999-25-BR.

- North Shore Bike Path Bridge Abutments Repair: Contract Award.
- The North Shore Bike Path will be improved by repairing six bridge abutments over the Skokie River, the Canadian National Railroad, and the Metra Railroad.
- This improvement will require relocation of overhead wires at the Metra bridge.
- Metra will perform the work to relocate the overhead wires at an estimated cost of \$40,000.
- A total of seven bids were received, ranging from \$618,683.50 to \$993,298, and the lowest responsible bidder is Alliance Contractors, Inc., Woodstock, Illinois, in the amount of \$618,683.50.

## 22 <u>16-1059</u>

Joint resolution appropriating \$30,000 of County Bridge Tax funds and \$149,000 of Matching Tax funds to provide for fiscal year (FY) 2017 acquisition of materials and services needed to maintain such items as drainage and bridge facilities, pavements, shoulders, guardrails, fencing, signage, and right-of-way, and designated as Section 17-00000-03-GM.

- FY 2017 Miscellaneous Maintenance Materials and Services, County Bridge Tax and Matching Tax: Appropriation.
- Before materials can be ordered, or work can be done using the County Bridge Tax fund or the Matching Tax fund, an appropriation is needed.
- This resolution appropriates \$30,000 of County Bridge Tax funds and \$149,000 of Matching Tax funds for miscellaneous maintenance work in FY 2017.

## 23 <u>16-1058</u>

Joint resolution appropriating \$82,500 of County Bridge Tax funds, \$137,100 of Matching Tax funds, and \$119,500 of ¼% Sales Tax for Transportation funds for fiscal year (FY) 2017 miscellaneous services needed to address items such as soil, environmental, drainage, bridge, wetland, and right-of-way purchases, and designated as Section 17-00000-02-EG.

- <u>FY 2017 Miscellaneous Services: County Bridge Tax, Matching Tax and ¼% Sales Tax</u> for Transportation Funds: Appropriation.
- Before miscellaneous services for construction projects can be done utilizing County Bridge Tax, Matching Tax and ¼% Sales Tax for Transportation funds, an appropriation is needed.
- This resolution appropriates \$82,500 of County Bridge Tax funds, \$137,100 of Matching Tax funds, and \$119,500 of 1/4% Sales Tax for Transportation funds to provide for miscellaneous services in FY 2017.

## 24 <u>16-1063</u>

Joint resolution appropriating \$165,000 of ¼% Sales Tax for Transportation funds for the FY 2017 Joint Utility Locating Information for Excavators, Inc. (JULIE) annual fee, ticket screening, and locating of Lake County Division of Transportation's (LCDOT) storm sewers for excavator dig requests for various County highways, and designated as Section 17-00000-09-GM.

- FY2017 Storm Sewer Locating Services: Appropriation.
- Pursuant to Illinois law, JULIE serves as a message handling notification service for underground facility owners regarding planned excavations.
- Storm sewers are included in the law and the LCDOT must mark the location of storm sewers at excavation sites.
- Before a project letting can be held, an appropriation of \$165,000 of ¼% Sales Tax for Transportation funds is necessary to provide for the JULIE annual fee, ticket screening, and locating of LCDOT storm sewers in FY2017.

## 25 <u>16-1099</u>

Joint resolution appropriating \$1,500,000 of Matching Tax funds for the resurfacing of Greenleaf Street, from Washington Street to Illinois Route 120, and designated as Section 15-00184-04-RS.

- Greenleaf Street Resurfacing: Appropriation.
- Greenleaf Street is in need of resurfacing, from Washington Street to Illinois Route 120.
- This resurfacing improvement has been identified within the County's pavement management system, and is included in the 2016 highway improvement program.
- This resurfacing project will include a culvert replacement and median landscape enhancements.
- Before a project letting can be held, an appropriation of \$1,500,000 of Matching Tax funds is necessary.

## 26 <u>16-1102</u>

Joint resolution authorizing an agreement with Amec Foster Wheeler Environment and Infrastructure, Inc., Chicago, Illinois, at a cost of \$77,844, for professional services for the provision of Phase II design engineering services to stabilize an existing sheet piling wall adjacent to the multi-use path on the north side of Grass Lake Road, appropriating \$90,000 of Matching Tax funds, and designated as Section 16-00059-11-BR.

- <u>Grass Lake Road 2018 Retaining Wall Maintenance, Phase II Design Engineering</u> Services: Consultant Agreement and Appropriation.
- This project includes stabilizing an existing sheet piling wall, adjacent to the multi-use path, on the north side of Grass Lake Road.
- A consultant will be utilized to undertake Phase II design engineering services, including a geotechnical investigation and report which will be used during the design process.
- In accordance with the Local Government Professional Services Selection Act, the selected, and recommended, firm is Amec Foster Wheeler Environment and Infrastructure, Inc., Chicago, Illinois, with a cost of \$77,844.
- This resolution authorizes the execution of the agreement with Amec Foster Wheeler Environment and Infrastructure, Inc., and appropriates \$90,000 of Matching Tax funds for these services.

## 27 <u>16-1073</u>

Ordinance amending Chapter 96, Recreational Vehicles on Land, of the Lake County Code of Ordinance to allow for enforcement by the Sheriff and municipal police of manual on uniform traffic control devices (MUTCD) signs placed on Lake County bike paths.

- <u>Chapter 96, Recreational Vehicles on Land, of the Lake County Code of Ordinance</u> <u>Revisions.</u>
- The local police agency and the Sheriff currently enforce the provision for no equestrian or motorized vehicles on the trail. There is a need to add the authority for the local law enforcement to be able to enforce other provisions related to regulatory signs on the trails systems, such as stop signs.
- This ordinance authorizes law enforcement to be able to enforce provisions in the MUTCD.
- The ordinance amends the enforcement fees, allowing an increase for second or subsequent violations.

#### 28 <u>16-1078</u>

Joint resolution authorizing a master agreement with the City of Waukegan regarding the energy, maintenance, and future costs of City owned traffic control signals and interconnection with Lake County PASSAGE.

- Traffic Signal Master Agreement, Lake County PASSAGE: City of Waukegan.
- The City of Waukegan operates, and has jurisdiction over, certain traffic control signals within its corporate boundaries.
- The City of Waukegan and Lake County wish to enter into a new agreement stating the terms and conditions for energy, maintenance, and future costs of City owned traffic control devices and interconnection with Lake County PASSAGE, allowing maintenance of the City signals to be included in the County's annual traffic signal maintenance contract.
- This resolution authorizes a new agreement with the City of Waukegan and takes the

place of and supersedes all prior agreements.

## 29 <u>16-1081</u>

Resolution approving the 2017 Lake County State and Federal Legislative Program.

- Annually, the County develops a list of priority projects that are submitted to State and Federal legislators who represent Lake County.
- The County's 2017 Legislative Program seeks to:
  - add Lake County to previously approved legislation permitting a judicial facilities fee not to exceed \$30 for the construction of judicial facilities;
  - implement a rule change to the administrative code to the Inmate Welfare Fund to allow the use of inmate welfare funds for basic medical care;
  - eliminate personal service and publication requirements for final take notices on vacant property;
  - amend the Election Code by removing the requirement for voters to sign the back of their vote-by-mail envelope;
  - continue support of the Illinois General Assembly's efforts to address the use of opiates;
  - amend the Illinois Underground Utility Facilities Damage Prevention Act to specifically exclude underground storm sewers located within County rights-of-way; and
  - o support the extension of the Illinois Affordable Housing Tax Credit.
- The County's 2017 Legislative Program also includes a federal component supporting
  efforts to clarify HIPAA so treatment providers may disclose concerns about patient
  safety to appropriate parties when they believe "in good faith" that there is a threat of
  "serious or imminent" danger to the patient or others.

County Street, Waukegan, Illinois to install, remove, replace, modify, maintain, and operate a communications facility including backup power sources and other associated equipment, fixtures, wiring, and cabling.
- The communications equipment will be owned by Motorola Solutions, Inc. and used for emergency service, public safety, and other governmental purposes as part of their STARCOM21 system.
- Motorola Solutions, Inc. shall be responsible for the maintenance of the

communications equipment and the existing uninterruptible power supplies, dehydrator, and air conditioning unit.

- The five year lease and utility payment is in the annual amount of \$4,220.46, which is inclusive of rent and utilities.
- It is hereby requested that the County Board Chair be authorized to execute the lease agreement with Motorola Solutions, Inc., Schaumburg, Illinois.

## 32 <u>16-1077</u>

Ordinance amending the Accelerated Retirement Option (ARO) Administrative Policy and authorizing the County Administrator to offer certain eligible employees the ARO.

- On October 11, 2016, the County Board approved an Ordinance authorizing the County Administrator to implement the ARO program to reduce headcount, allow for planned department restructuring, and reduce on-going costs for the County.
- A long term benefit of the ARO is that the County could evaluate existing departmental operations along with vacancies created by the ARO; and then, consider opportunities to enhance customer service, gain efficiencies, and reduce expenses.
- Eligible employees will be allowed to continue health insurance and dental benefits for two years by making contributions at the same monthly rate as full-time regular employees; OR
- Eligible employees will be allowed to continue health and dental insurance benefits for one year by making contributions at the same monthly rate as full-time regular employees and will receive one week of pay for every two years of service above seven years.

- At this time, staff seeks to change the effective date in option two to allow the ARO to be based upon the rate of pay in effect as of fiscal year 2017, provided the employees separation date is in fiscal year 2017.
- Staff requests approval to eliminate provisions related to health and dental insurance as it applies to coverage provided by union sponsored plans.
- Staff seeks authority for the County Administrator to negotiate an agreement with the Collective Bargaining groups, provided the terms of the agreement results in a saving that is equal to or more then similarly situated non-union employees. The County Board Chairman shall authorize any negotiated agreement.

#### 33 <u>16-1079</u>

Joint resolution authorizing an emergency appropriation of Wetland Restoration Funds in the amount of \$370,215 for the purchase of 3.842 acres of wetland mitigation credit to replace 2.58 acres of isolated wetlands lost due to development impacts.

- The Stormwater Management Commission (SMC) Wetland Restoration Fund (WRF) collects fees from wetland impacts into a deferred revenue account for each of the four major watersheds in the county.
- Once the fund reaches a threshold value or credits become available within a watershed wetland bank, the WRF policies mandate a financial process, which requires an emergency appropriation to allocate funds for expenditure.
- On October 6, 2016, the SMC approved the expenditure of \$<u>370,215</u> to purchase 3.842 acres of wetland mitigation credit at the Atkinson Road Wetland Mitigation Bank (North Branch of the Chicago River) in order to replace 2.58 acres of isolated wetlands lost due to development impacts.

## 34 <u>16-1084</u>

Joint resolution authorizing an emergency appropriation in the amount of \$260,095 in the Stormwater Management Commission (SMC) budget, Fund 212, to be reimbursed by the East Skokie Drainage District (ESDD) for a Wetland Mitigation Project in the City of North Chicago, Illinois.

- SMC has entered into an intergovernmental agreement with the ESDD for site excavation, material haul off, wetland revegetation, and maintenance and monitoring for a phased Wetland Mitigation and Public Flood Control Project in the City of North Chicago.
- SMC will prepare engineering plans, complete bid and contractor selection, perform construction management, and conduct short-term maintenance and monitoring. ESDD will perform long-term maintenance and monitoring after wetland mitigation performance standards have been achieved.
- ESDD will reimburse SMC the cost to perform engineering, construction, and short-term maintenance and monitoring up to \$260,095. No SMC or Lake County matching funds are required for this project phase.

## 35 <u>16-1080</u>

Joint resolution accepting the U.S. Department of Justice, Office of Justice Programs grant and authorizing an emergency appropriation in the amount of \$250,000 for the implementation of the Lake County Crisis Intervention Team (CIT) Program.

- In May 2016, in an effort to address mental health and substance abuse issues that affect law enforcement, the Sheriff's Office submitted a grant application to the U.S. Department of Justice, Office of Justice Programs to assist with costs associated with implementing a Crisis Intervention Training (CIT) Program.
- The goal of the grant is to coordinate training for 395 police officers and dispatchers within the three year grant period and to develop a response model for law enforcement throughout Lake County that will aid approximately 6,000 persons in crisis each year.
- The long-term goal is to provide CIT to all law enforcement, mental health professionals and those who have community contact with persons suffering from mental illness or substance abuse issues throughout Lake County.
- Emergency appropriation of grant funds in the amount of \$250,000 must be approved and the Sheriff's Office FY17 Budget modified to include the \$250,000.

- Community Development has entered into a Substantial Amendment with HUD to invest NSP3 grant funds.
- The purchase, rehabilitation and resale to income-eligible buyers of NSP3 homes generates program income that must be reinvested in Lake County's NSP3 program.
- HUD will reimburse Lake County the remaining costs of its NSP3 program up to \$174,569.89 (previous grant availability \$84,366.74 in excess of budget plus \$90,203.15 of NSP3 program income received in FY16). No Lake County matching funds are required for this program.
