## 13 <u>17-0009</u>

Joint resolution authorizing an Intergovernmental Agreement with the Villages of Lake Barrington and North Barrington for continuation of Police Services.

- The Villages of Lake Barrington and North Barrington have agreed to continue the police services contract for a three-year period.
- Based on population served, the Village of Lake Barrington pays 57.5 percent of the total monthly cost and the Village of North Barrington pays 42.5 percent of the total monthly cost.
- The Village of Lake Barrington will pay \$494,784.51 in 2017, \$510,096.99 in 2018, and \$528,532.41 in 2019 for police services. The Village of North Barrington will pay \$365,710.29 in 2017, \$377,028.21 in 2018, and \$390,654.39 in 2019 for police services.
- Three full time equivalent officers plus a shift relief factor will provide police services, continuing the 24-hour, one-car-per-shift, coverage to be provided by the Sheriff's Office.
- This new contract incorporates the cost of 911 dispatch services into the pricing structure of the contract, all other hourly rate charges are consistent with newer County police services contracts. The annual increase is sufficient to cover costs associated with this contract.

## 14 <u>17-0012</u>

Joint resolution approving the Memorandum of Understanding (MOU) between the Lake County Sheriff's Office and the United States Marshals Service.

- The Lake County Sheriff's Office Warrants Division will continue to pursue Lake County warrants, with the primary focus being warrants that fit the criteria for a Federal Identification (FID) Number. Working with the Marshals Service does not mean a change in our Standard Operating Procedures.
- The deputies that serve on the Regional Fugitive Task Force will receive training and equipment and have the ability to utilize the state of the art virtual training facility that the Marshals have in Chicago.
- Participation on the task force means that we will have the authority to travel to other states to assist with fugitive apprehension and the task force will assist with international extraditions.
- The Sheriff's Office will be eligible to receive overtime reimbursements from the United States Marshals Service, for up to \$17,000 annually, for when they attempt to serve task force warrants.

## 15 <u>17-0071</u>

Resolution authorizing an emergency appropriation of two grants totaling \$58,295.85 from the D. A. S. Charitable Fund for the preservation of feline animal life for use by the Sheriff's Office Canine Unit.

- The D.A.S. Charitable Fund is a trust that provides grant funds for the care and training of canines.
- D.A.S. grants cannot be used to fund equipment, vehicles or police salaries, and do not require matching funds or that the Canine Unit add additional vehicles to its fleet.
- The first grant covers \$37,413 in expenses related to the procurement and training of the Canine Unit's new bomb dog. The second grant covers \$20,882.85 for the annual operating costs associated with the Canine Unit's four canines, including veterinary services, food and kennel costs and training of Lake County's four canines.
- The grants require the Canine Unit to file quarterly reports that inform the Fund about its canine usage during the year.

## 16 <u>17-0013</u>

Joint resolution authorizing a continued participation fee of \$42,000 for the State's Attorney's Appellate Prosecutor Program for fiscal year (FY) 2017.

- This is a renewal for the continued operation of the State's Attorney's Appellate Prosecutor Program.
- Through this program the State's Attorney's Appellate Prosecutor handles Lake County criminal appeals, provides investigative and prosecutorial support in criminal cases, provides comprehensive training programs for prosecutors, and provides monthly case law newsletters, legislative updates, and Uniform Complaint Book supplements.
- The Board of Governors of the State's Attorney's Appellate Prosecutor has voted to keep the Lake County State's Attorney's Office contribution for FY2017 the same as for FY2016, or \$42,000.
- The State's Attorney's approved FY2017 budget includes the \$42,000 fee.

## 17 <u>17-0028</u>

Joint resolution accepting the 2017 National Crime Victims' Rights Week (NCVRW) Community Awareness Project sub-grant and authorizing an emergency appropriation in the amount of \$5,000.

- Since 1981, National Crime Victims' Rights Week (NCVRW) has annually been observed in April and seeks to increase public awareness and knowledge about the wide range of rights and services available to people who have been victimized by crime.
- A \$5,000 sub-grant was awarded to the State's Attorney's Office by the National Association of Victims of Crime Act (VOCA) Assistance Administrators (NAVAA) under a VOCA grant from the Office for Victims of Crime, within the Office of Justice

Programs, U.S. Department of Justice.

- The 2017 NCVRW theme is "Strength Resilience Justice."
- The program funds will be used during the 2017 NCVRW, April 2-8, 2017, to promote community awareness of crime victims' rights and services and will support the purchase of NCVRW promotional giveaways, event supplies, a speakers fee and accommodations, announcements, and recognition awards.
- The source of program funding is 100 percent federal VOCA; no match is required.

## 18 <u>17-0047</u>

Joint resolution authorizing a contract with Interior Concepts, Inc., of Lincolnwood, Illinois, and further authorizing assignment of that contract to Clark Construction Group LLC of Chicago, Illinois, as Construction Manager at Risk (CMAR) for the window blinds and shades work for the Lake County Courthouse Expansion Project in the amount of \$85,950.

- The window blinds and shades work in this bid generally includes supply and installation of all window blinds and shades for all phases of the Courthouse Expansion Project.
- The Lake County Board has authorized Clark Construction Group, LLC of Chicago, Illinois, to proceed with a Guaranteed Maximum Price (GMP) for the infrastructure & interior work pursuant to their contract for CMAR services.
- A bid was issued for window blinds and shades work on August 15, 2016.
- Sealed bids were received on October 6, 2016, from two nonlocal vendors ranging from \$85,950 to \$110,000.
- Interior Concepts, Inc., of Lincolnwood, Illinois, was determined to be the lowest responsive and responsible bidder.
- This resolution awards the contract to Interior Concepts, Inc., of Lincolnwood, Illinois, of Lincolnwood, Illinois, and assigns the contract to Clark Construction Group LLC to manage as part of the GMP for this work.

## 19 <u>17-0049</u>

Joint resolution authorizing a Professional Services Contract with Robison Guarnery Inc. of Gurnee, Illinois, for the development of two separate assessments including a Jail Medical and Laundry Long Term Master Plan and an Inmate Court Movement and Supervision Study in the amount of \$74,000.

- Lake County desires to enter into a Professional Services Contract for development of two separate assessments including a Jail Medical and Laundry Long Term Master Plan and an Inmate Court Movement and Supervision Study.
- The Jail Medical and Laundry Long Term Master Plan will assist the County in evaluating these two functional areas, identifying limitations, projecting their growth needs, and developing operational and architectural solutions.
- The Inmate Court Movement and Supervision Study will assist the County in determining the most efficient and secure model for inmate movement to and from the new Court Expansion Project currently under construction.
- Scope of work includes comprehensive project representation, project needs assessments, program development, production of preliminary design options and cost estimates, team building and consensus, and all other representative services ancillary to completing these assessments.
- The project team will consist of Robison Guarnery Inc. of Gurnee, Illinois, providing

Owner's Representation services, CGL Companies providing jail planning expertise, Kluber Architects providing architectural support, and other subordinate planning consultants.

- The firm of Robison Guarnery Inc. of Gurnee, Illinois, has been determined to be uniquely qualified to deliver these services based on previous experience providing both project management and architectural services on Lake County Justice Agency projects since the early 1990's. Some examples of this experience include the Branch Courts in Round Lake Beach and Park City, the Probation Department Remodeling, the Public Defender Remodeling, and the Lake County Courthouse Expansion projects.
- Lake County has a prior satisfactory relationship with Robison Guarnery Inc. of Gurnee, Illinois, and these services are in accordance with the Purchasing Ordinance, and the Local Government Professional Services Selection Act.

## HEALTH AND COMMUNITY SERVICES COMMITTEE

## 20 <u>16-0872</u>

Joint resolution approving First Amendment to the 2016 Housing and Urban Development (HUD) Action Plan.

- HUD requires the submission of an Annual Action Plan and associated amendments to govern expenditure of federal housing and community development funding for each year of grant funding.
- The Lake County HOME Investment Partnership (HOME) Consortium is comprised of Lake County and the Cities of Waukegan and North Chicago; all three jurisdictions receive Community Development Block Grant (CDBG) funding.
- The proposed Action Plan amendments reflect recommendations made by the Housing & Community Development Commission (HCDC) on September 14, 2016. The proposed changes are highlighted in yellow in the attached Action Plan.
- At the final HCDC action and Public Hearing held on November 9, 2016, the proposed amendments received no negative public comment.

## 21 <u>17-0033</u>

Joint resolution authorizing a contract with IHC Construction Companies LLC, of Elgin, Illinois, in the amount of \$2,358,726 for the East Main Pump Station Project.

- The East Main Pump Station, was originally constructed in 1980. Located in the Northwest sewer system, the pump station is one of the County's largest wastewater pump stations with an average daily flow of four million gallons per day. It accepts flow from Round Lake, Round Lake Beach, Round Lake Heights, Round Lake Park, Hainesville, Lake Villa and Lakes Region Sanitary District and transmits it to the Northwest Regional Water Reclamation Facility in Fox Lake.
- This project will include the replacement of pumps, electrical and motor control equipment, upgrades to energy efficient lighting, HVAC and roof replacement.
- An invitation to bid was extended to 10 vendors and sealed bids were received from three local and three non-local contractors ranging from a total of \$2,374,200 to \$2,596,000.
- IHC Construction Companies LLC, of Elgin, Illinois was determined to be the lowest responsive and responsible bidder who best meets the needs of the County in the amount of \$2,358,726.

## 22 <u>17-0032</u>

Joint resolution authorizing execution of an agreement with Christopher B. Burke Engineering, Ltd., of Rosemont, Illinois, in the amount of \$145,974 for construction engineering services for the East Main Pump Station Project.

- The East Main Pump Station is a major wastewater pumping facility and a key component of the northwest sanitary sewer collection system. It has been in continuous service for over 35 years.
- Major mechanical and electrical equipment at the facility (pumps, motor control center, valves, and electrical systems) will be replaced and upgraded to ensure future, continuous safe operation.
- Engineering construction services are needed for review of shop drawings, field inspections and to resolve field conditions with the general contractor to ensure that proper replacements, repairs and upgrades are performed in compliance with the plans and specifications.
- Lake County has a prior satisfactory relationship with Christopher B. Burke, Ltd., of Rosemont, Illinois and these services are in accordance with the Purchasing Ordinance and the Local Government Professional Services Selection Act.

#### 23 <u>17-0031</u>

Joint resolution authorizing execution of a professional services agreement with RJN Group, Inc., of Wheaton, Illinois, in the amount of \$190,753 for engineering services for the 2017 Infiltration and Inflow Reduction Program.

- The purpose of this project is to install, maintain and operate sanitary sewer flow monitoring stations in portions of the Northwest, Northeast Central and Southeast Lake Sewer Systems, and to perform sewer inspections in areas with known Infiltration and Inflow, as identified by a previous flow monitoring project.
- The County provides wholesale sanitary sewer service, by contract, to several municipalities including Round Lake, Round Lake Park, Round Lake Beach, Round Lake Heights, Hainesville, Fox Lake, Lake Villa, Gurnee, Grayslake, Third Lake, Kildeer, Lake Zurich, Hawthorn Woods, Long Grove, Deerfield, Buffalo Grove, Riverwoods, Lincolnshire and unincorporated portions of northwestern, northeast central and southeastern Lake County.
- The data collected will be used in developing engineering solutions to reduce wet weather infiltration and inflow into the sanitary sewer systems.
- Lake County has a prior satisfactory relationship with RJN Group, Inc., for work of similar nature on County projects and these services are in accordance with the Purchasing Ordinance and the Local Government Professional Services Selection Act.

#### 24 <u>17-0020</u>

Joint resolution appropriating \$715,000 of Matching Tax funds for annual bituminous maintenance of various roads and bike paths on the County highway system, and designated as Section 17-00000-13-GM.

2017 Bituminous Maintenance: Appropriation.

- Each year, the County undertakes maintenance of its bituminous highway pavements, shoulders, and bike path pavements to preserve the surface quality.
- Before a project letting can be held, an appropriation of \$715,000 of Matching Tax funds is necessary.

## 25 <u>17-0021</u>

Joint resolution appropriating \$300,000 of Matching Tax funds to provide for crack sealing of bituminous and concrete pavement, where necessary, on various County highways, and designated as Section 17-00000-04-GM.

- 2017 Crack Sealing: Appropriation.
- Each year, crack sealing is done to County highways to prevent the intrusion of water and incompressible material into the cracks and to reinforce the adjacent pavement.
- Before a project letting can be held, an appropriation of \$300,000 of Matching Tax funds is necessary.

## 26 <u>17-0022</u>

Joint resolution appropriating \$50,000 of Motor Fuel Tax funds for the 2017 repair and replacement of various guardrail and fence installations, and designated as Section 17-00000-06-GM.

- 2017 Guardrail and Fence Maintenance: Appropriation.
- The County owns miles of guardrails and fences along the County highway system, and annual repairs and replacements must be made to various installations.
- Before the purchase of material or a contract service can be procured, an appropriation of \$50,000 of Motor Fuel Tax funds is required.

## 27 <u>17-0023</u>

Joint resolution appropriating \$50,000 of Matching Tax funds for landscape inspection and maintenance, including trees and shrubs, along various County highways, and designated as Section 17-00000-17-GM.

- <u>2017 Landscape Maintenance: Appropriation.</u>
- The County maintains the landscape, including trees and shrubs, on various projects on the County highway system that require inspection and maintenance.
- This inspection and maintenance will be done by a contractor.
- Before quotes can be received, an appropriation of \$50,000 of Matching Tax funds is needed.

## 28 <u>17-0024</u>

Joint resolution appropriating \$110,000 of Matching Tax funds for inspection and maintenance of recently planted native landscape areas along various County highways, and designated as Section 17-00000-14-GM.

- <u>2017 Native Landscape Maintenance: Appropriation.</u>
- The County has planted native landscape areas for various projects on the County highway system that require inspection and maintenance.
- This maintenance will be done by a contractor.
- Before a project letting can be held, an appropriation of \$110,000 of Matching Tax funds is needed.

## 29 <u>17-0050</u>

Joint resolution authorizing a cooperative purchasing contract with K-Tech Specialty Coating, Inc., of Ashley, Indiana, for liquid calcium and magnesium chloride

deicer/anti-icer with sugar beet molasses based corrosion inhibitor solution for use during the 2017 snow and ice season, appropriating \$120,000 of Matching Tax funds, and designated as Section 17-00000-19-GM.

- <u>2017 Snow and Ice Control Deicing Liquid: Appropriation.</u>
- Lake County Division of Transportation (LCDOT) will be using liquid calcium and magnesium chloride deicer/anti-icer with sugar beet molasses based corrosion inhibitor solution during the 2017 snow and ice season.
- Pursuant to Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake County may participate in a cooperative purchasing agreement for the procurement of goods with one or more public procurement units in accordance with an agreement entered into between the participants.
- Staff has identified a joint purchasing opportunity through a recently awarded contract by Warren Township Highway Department with K-Tech Specialty Coating, Inc., of Ashley, Indiana, for the procurement of liquid calcium and magnesium chloride deicer/anti-icer with sugar beet molasses based corrosion inhibitor solution.
- The cooperative purchasing contract with K-Tech Specialty Coating, Inc., of Ashley, Indiana, is a unit price contract with LCDOT.
- This resolution appropriates \$120,000 of Matching Tax funds for fiscal year 2017.

Joint resolution authorizing a contract with Peter Baker & Son Company of Lake Bluff, Illinois, in the amount of \$660,712.24, for the patching/resurfacing of Lewis Avenue, from 14th Street to Belvidere Street, and designated as Section 16-00082-08-RS.

Joint resolution authorizing an agreement with Hampton, Lenzini & Renwick, Inc., of Elgin, Illinois, at a maximum cost of \$52,302.38, for Phase II design engineering services to install conduit and fiber optic along US Route 45 and along Hawley Street in Mundelein to connect additional traffic signals and Pan-Tilt-Zoom (PTZ) cameras to the Lake County PASSAGE system, appropriating \$65,000 of 1/4% Sales Tax for Transportation funds, and designated as Section 17-00268-16-TL.

- In accordance with the Local Government Professional Services Selection Act, the selected and recommended consultant is Hampton, Lenzini & Renwick, Inc., of Elgin, Illinois, at a maximum cost of services of \$52,302.38.

## 33 <u>17-0054</u>

Joint resolution appropriating \$6,440,000 of ¼% Sales Tax for Transportation funds for the acquisition of necessary right-of-way, by agreement or condemnation, and other right-of-way costs associated with the Weiland Road Reconstruction, from Lake Cook Road to Aptakisic Road, and designated as Section 14-00158-11-WR.

- <u>Weiland Road Reconstruction, Right-of-Way Acquisition: Appropriation with</u> <u>Condemnation Authority.</u>
- Preliminary plans and specifications for this improvement have been prepared.
- Before right-of-way acquisitions can proceed, authority for appropriation and condemnation is necessary.
- An appropriation of \$6,440,000 of 1/4% Sales Tax for Transportation funds is required.

## 34 <u>17-0057</u>

Joint resolution appropriating \$390,000 of ¼% Sales Tax for Transportation funds for the advance acquisition of a parcel necessary for right-of-way, by agreement, and other advance right-of-way costs associated with the intersection improvement of Fremont Center Road, at Illinois Route 60, and designated as Section 12-00138-02-CH.

- <u>Fremont Center Road Intersection Improvement, at Illinois Route 60, Advance</u> <u>Right-of-Way Acquisition: Appropriation.</u>
- Preliminary plans and specifications for this improvement have been prepared.
- Property for right-of-way is needed from the parcel identified as PIN #10-16-200-002, and an advance agreement has been reached.
- An appropriation of \$390,000 of 1/4% Sales Tax for Transportation funds is necessary for this parcel and other advance right-of-way costs.

## 35 <u>17-0053</u>

Joint resolution appropriating a supplemental amount of \$1,000,000 of ¼% Sales Tax for Transportation funds for the acquisition of necessary right-of-way, by agreement or condemnation, and other right-of-way costs associated with the Rollins Road Gateway Improvement at the intersections of Illinois Route 83/Rollins Road/Hainesville Road, and designated as Section 08-00080-56-BR.

- <u>Rollins Road Gateway Improvement, Right-of-Way Acquisition: Supplemental</u> <u>Appropriation with Condemnation Authority.</u>
- The improvement of the intersections of Illinois Route 83/Rollins Road/Hainesville Road, which includes construction of a grade separation of the Canadian National Railroad (CNRR), is a chosen project for the transportation challenge bond program.
- Before right-of-way acquisitions can continue, a supplemental appropriation is necessary.
- The County Board, at its meeting of April 12, 2016, approved a supplemental appropriation of \$600,000 for the right-of-way acquisition, and associated costs, based upon the extension of the acquisition process.

Joint resolution approving Change Order Number One for Agreement #14198 for the lease and management agreement between the County of Lake, Illinois, and Transitional Care of Lake County, LLC, (TCLC) of Rosemont, Illinois.

- In 2015 Lake County and TCLC entered into an Operations Transfer Agreement and a Lease and Management Agreement (collectively, the "Agreements") for the County's skilled nursing facility known as Winchester House in the amount not to exceed \$6,714,133.
- Since 2015, the need has arisen to modify the current lease and management agreement due to revenue shortfalls at Winchester House, which rendered the original pro forma, which was part of the lease and management agreement, inaccurate.
- The revenue shortfalls were attributed, at least in part, to an unforeseen, inaccurate and lower-than-expected census at Winchester House, with some residents having no payor source identified by the prior management company, Health Dimension Group (HDG).
- To remedy the shortfalls, the County worked with TCLC to rework the pro forma and negotiate a modification to the previously approved 2015 Lease and Management Agreement.
- The modifications require County Board approval because the recommendations are changes to the original 2015 agreement.
- The proposed modification includes extending the original three-year deal into a fourth year, if TCLC requires the additional time due to construction and regulatory delays and providing an additional six months of incentive payments in the amount of \$192,000.
- The County has negotiated revisions to various milestones to better reflect the progress thus far, and the anticipated progress which, again, may go into a full fourth year.

- The 2015 agreement's pro forma has been replaced with a revised pro forma.
- Importantly, the agreement modifications are contingent on TCLC doing the following:
  (1) Closing on the property in Mundelein for which the company has a real estate contract; and (2) Soliciting bids for construction.
- The proposed modified agreement includes the following additional notable County concessions:
  - Reduced rent and utilities payments. (This reduction is due, in part, to the fact that TCLC is using significantly less of the facility than originally anticipated.)
  - The County will also forgo future rent and utilities to the extent that delays are due to construction or regulatory challenges outside of TCLC's control.
  - Forgiveness of \$900,000 in already-budgeted start-up capital. (This is money the County has already paid to TCLC at the beginning of our agreement, not new money that the County must appropriate.)
  - Future forgiveness of the remaining, already-budgeted, start-up capital (\$1,031,957), provided construction milestones are met. (The \$1,031,957 start-up capital is already included in the original lease amount of \$6,700,00. Also, if construction does not begin by June 22, 2018, then the County does not agree to forgive this part of the start-up capital.)
  - The parties are deleting the "Shared Saving" provision of the Lease to simplify the financial accounting going forward.
- TCLC's major concessions include the following:
  - In lieu of shutting down Winchester House without a completed transition, TCLC will continue working with the County to surmount the various operational and development issues that the company has faced, and will continue towards the parties' ultimate goal of safely transitioning the residents of Winchester House to a modern, much improved facility in the near future.
  - The company releases the County from claims it might have had arising from "the revenue shortfalls due to residents without payor sources, the unanticipated expenses for health care, and the unanticipated expenses for workers' compensation."
- Change Order Number One increases the amount of the lease incentive payments by \$192,000 from \$6,714,133 for a total of \$6,906,133.
- In accordance with Article 8, Section 101 (1) of the Lake County Purchasing Ordinance it is hereby requested that the County Board Chair be authorized to enter into Contract Modification Number One.

Joint resolution reducing the County Diamond/Sylvan Lake sewer connection fee from \$9,110 to \$4,555 per residential customer equivalent (RCE) for the Transitional Care of Lake County (TCLC), also known as Transitional Care of Mundelein, facility.

- TCLC is proposing to construct a 185-unit skilled nursing facility in Mundelein, Illinois, which will replace the current Winchester House operation.
- The new TCLC Mundelein facility will be located within Lake County's Diamond/Sylvan Lake sewer service area, which due to its residential area, has a connection fee rate of \$9,110 per residential customer equivalent (RCE).
- As the County Board knows, Winchester House is a Medicaid facility with very low margins and it is expected that the replacement facility in Mundelein will also have a

significant number of Medicaid clients.

- Based on a fee reduction request and a desire to support the replacement of the Winchester House operation, it is proposed that the sewer connection fee rate for the TCLC facility be lowered from \$9,110 to \$4,555 per RCE, a 50 percent reduction.
- This resolution reduces the Lake County sewer connection fee, to be imposed upon the TCLC Winchester House replacement facility, from \$9,110 to \$4,555 per RCE.
- The proposed sewer connection fee reduction, if approved, will result in an approximate sanitary sewer connection fee of \$417,182.50.

## 53 <u>17-0052</u>

Joint resolution authorizing an agreement with the City of Park City to install and maintain the landscape median on Greenleaf Street, north of Illinois Route 120, and designated as Section 15-00184-04-RS.

- The issuance of the notes will benefit the public health and safety by providing adequate, decent, safe, sanitary and affordable housing to persons within the County.
- The borrower anticipates that it will employ approximately 50 individual contractors during the construction and rehabilitation period (with approximately 75 percent of the materials used to be procured from Lake County suppliers and/or manufacturers).
- The resolution approves and authorizes the issuance of the revenue notes and the execution of a Borrower Loan Agreement, a Funding Loan Agreement, a Tax Regulatory Agreement and other agreements, documents and instruments in connection with the foregoing.
